### QiY 16/10/05      Student Presentation

Seven students from The Mount and Bootham have collaborated in sharing with us the experiences they have had in learning about Quakers and Quakerism. The presentation covered their retreat to Woodbrooke, PeaceJam, Bootham

Environmental and Sustainability Team (BEAST), and the Quaker Pilgrimage. They gave us examples of how their learning has been incorporated into their day-to-day activities and witness. These include using meetings for clearness, activities through PeaceJam to bring about change, notably the LifeBag Project and BEAST's focus on local environmental improvements such as renegotiating a landfill project. The Pilgrimage, during which they visited Swarthmore Hall, Pendle Hill, the Quaker Tapestry and Firbank Fell, taught them many things including the value of Quaker silence as an opportunity for people of all backgrounds to find the spiritual truth which speaks to them individually, and respect for individuals.

### **QiY 16/10/12      The Retreat**

Our clerks have received notice from John Miles, Clerk to the Members of The Retreat of the proposal to make changes to arrangements for appointing governors of The Retreat. The details of the proposals have been circulated with the October QiY Newsletter, and we have Malcolm Bowker from the Retreat governing body with us today who has answered questions. The principal change is that QiY will no longer appoint Friends to serve as governors but will appoint Friends to serve on a nominating group who will be responsible for finding and nominating the governors. Our Nominations Committee has agreed to the change, and after reflection we are happy to agree to the changes as they stand.

We also agree to receive a report from The Retreat at an interval agreed by QiY Arrangements Committee.

We understand that this minute will be reported to The Retreat Trustees for presentation to a general meeting of the members of the Retreat on 24 November. If endorsed and if these changes are implemented, then we ask QiY Trustees to make the necessary amendments to the QiY governing document.

### **QiY 16/10/13      Stephen Pittam**

We have welcomed Stephen Pittam, formerly with the Joseph Rowntree Charitable Trust, who has been involved in a number of activities which fall

broadly under the umbrella of human rights. His focus today has been on how the principles apply at a local level and the role Quakers have played.

Human rights flow naturally from our testimonies, especially peace and equality. They are particularly important for those who are disadvantaged or disempowered. The impending repeal of the Human Rights Act anticipated under the present government and its replacement by a British Bill of Rights, which will inevitably be weaker, is a cause for dismay.

There is an overwhelming feeling in the community at large that human rights apply to others, not to us. But they **do** apply to us and have been secured after great efforts. York is very important. The Centre for Applied Human Rights at York University, which welcomes activists and thinkers from many locations in the world, is a precious and indispensable institution in our community. International Service in York is the only overseas volunteering agency based outside London and operates in a human rights context.

The Joseph Rowntree Charitable Trust, also in York, has supported human rights work in the UK. The hoped-for Human Rights Commission planned by the Labour Government did not materialise unfortunately. So the position was that human rights were seen to be not relevant to most people's lives.

The initiative to establish York as a Human Rights City grew out of the realisation that there are Human Rights Cities in Africa, South America, North America and in Europe and the coming together of the University Centre of Applied Human Rights, York City Council, North Yorkshire Police, York CAB, International service and York CVS.

Stephen outlined the vision and objectives as well as the work that has been done. A research project probed respondents to identify the five rights they identified as important. These were education, non-discrimination and equality, health, an adequate standard of living and affordable housing. Five hundred people responded. December will see the launch of their report. The group have embarked on education and training, for example with City of York Council and voluntary sector leaders. This showed a growing awareness of how a human rights framework could be applied to their work.

The public launch will be in 2017. Stephen emphasised the long term nature of this work and the antipathy towards human rights from certain political figures and elements of the media. Our Human Rights Act is under serious threat. However, it has been used to instigate investigations into various injustices, some more publicised than others – for example the enquiry into the Hillsborough disaster, deaths at hospitals and army barracks. The planned repeal is a source of great concern.

A number of questions illustrated how the European Convention on Human Rights protects us all and Stephen listed a number of these rights. The Act came about after the end of World War II and there is great concern over the present Government's focus on eliminating these rights especially as the proposed British Bill of Rights would apply to British people only. Keeping the

legal avenues open is essential. Perhaps Quakers can partner the many other organisations who are feeling concern? Despite the existence of charity law to which we are bound, there is still room for dissent.

We thank Stephen for his stimulating presentation and for his encouragement for us as Quakers to consider our role in maintaining human rights. A copy of Stephen's report will be on the QiY website.
